
After careful examination on the information contained in reference read above and in pursuance of the recommendation of the inspecting Officer, in the letter 4<sup>th</sup> read above, the District Educational Officer, Nizamabad is pleased to accord **Extension of Temporary Recognition for classes Nursey to V (E/M) for the period from 2025 - 2026 to 2034 - 2035 in respect of Knolwedge Park School, Autonagar, Bodhan Road, Nizamabad North(M), Nizamabad District without aid** subject to the following conditions.

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from time to time.
2. That the Institution shall adopt the Curriculum & Syllabus prescribed by the Government time to time.
3. The School timings Vacations and Mid – term holidays shall be as prescribed by the Government.
4. That the records / accounts shall be furnished to the District Educational Officer every year.
5. That the list of Governing Body to be furnished to the District Educational Officer every year.
6. That the Pay structure / Fee structure fixed by the Governing body shall be approved by the District Educational Officer every year.
7. That all the conditions prescribed in the G.Os and other orders which are specified in these Orders shall be complied with.
8. That the Society shall provide the necessary amenities like accommodation, Sanitary facilities, Drinking water facilities, Furniture, Library, Laboratory, Equipments, Required qualified trained Staff as per the staff pattern and other facilities are necessary before approaching the competent authority.

9. That the society shall submit the Proposals for renewal of Provisional Recognition in advance i.e., at least 6 months prior to the date of expiry of the renewal.
10. That the permission accorded is restricted to these years only and it is not valid for the subsequent academic year.
11. That the permission is accorded to the above said society only and no other society or body can open a school on their behalf.
12. The permission is accorded to open the school in the specified locality and there shall not be any change in the premises or locality.
13. The society shall provide the necessary material even if it costs more than the deposit amount.
14. That the management shall provide 500 library books in the school library immediately.
15. The society shall establish the Fire extinguishers in the School.
16. The Pre-Primary Classes shall run in ground floor only.
17. The Play equipment of Pre-Primary Classes Shall be non plastic and No sharp edges material shall not allowed.
18. The Management shall fulfill all above conditions within two months failing which the Recognition will be automatically withdrawn.

Permission/ Extension of Temporary Recognition has been accorded to the Class (s) VI to X (E.M) for the years 2010-2011 to 2019-2020 in respect of Knowledge Park International School, Autonagar, Bodhan Road, Nizamabad North (V&M), Nizamabad District in the orders 5<sup>th</sup> cited. The inspecting authority has submitted the report for provisional recognition to the school for the years 2020-2021 to 2029-2030 vide letter 6<sup>th</sup> cited. The Dist. Ednl. Officer, Nizamabad Dist. has verified the application for provisional recognition with reference to the inspection report of the Inspecting officer and also with reference to the conditions laid down in the permission order/previous recognition orders and G.O Ms.No.1Edn, (PS.2) Dept, dt.01.01.1994 and submitted a report in his letter 7<sup>th</sup> cited.

After careful examination of the references cited and the conditions prescribed in G.O. Ms. No.1/Edn, (PS.2) Dept, dt.01.01.1994 and based on the recommendations of the DEO, Nizamabad Dist., the Regional Joint Director of School Education, Hyderabad hereby accorded Provisional/ Extension of Temporary Recognition to Class(s) VI to X (E.M) for the years 2020-2021 to 2029-2030 in respect of Knowledge Park International School, Autonagar, Bodhan Road, Nizamabad North (V&M), Nizamabad Dist. subject to fulfillment of conditions as detailed below:

1. That the Educational Society shall abide by the instructions/rules issued by the Govt. from time to time.
2. That the educational Society shall serve the needs of locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time by the State Government.
4. That the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
5. That the qualified staff within age limits prescribed by the Govt. for Government employees shall be appointed as per the staff pattern as per G.O Ms.No.103 Edn (PS), dt.05-08-2005.
6. That the results shall be satisfactory every year and not to be announce the ranks in SSC Public Examinations as per the G.O Ms.No.49 Edn. (PS), dt.26.02.98.
7. That the records/accounts shall be furnished to the D.E.O every year by 31<sup>st</sup> March, at the latest.
8. That the list of governing body shall be furnished to the DEO every year.
9. That the pay structure / fee structure fixed by the governing body shall be got approved by the DEO every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall complied with.
11. That the school shall not be closed without giving notice both the Parents/DEO and competent authority at least (6) months before.

12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
14. That additional sections/higher classes should not be opened without prior permission of the competent authority.
15. That the recognition is accorded to society and no other society or body can open a school on their behalf.
16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
17. The society shall provide the necessary material even if it costs more than the deposit amount.
18. Admissions should be made on the basis Record sheet issued by the Private Recognized/ZP/Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bonafide candidate.
19. The Edn. Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt. from time to time by the end of April every year as per G.O.3<sup>rd</sup> cited.
20. The above E.T.R. is granted subject to condition that, If it is found later that the school has not fulfilled the prerequisite condition under A.P. Edn. Act 1982, reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once.
21. The Management shall provide sufficient transportation, sufficient fire extinguishers in the school.
22. The Management is totally responsible in all aspects for the safety of school children. They will be personally held responsible if any incident occurs.
23. The Management shall handover the school premises whenever required to this department / Government for emergency purpose (Exams/ Elections etc) without any deviation of the orders.
24. G.O.Ms.NO.22, dt.18.07.2017 must be compulsorily followed i.e., the weight of School bag not to exceed 4 Kg for VI-VII, 4.5 Kg for VIII-IX and 5 Kg for X.
25. The Management not to run I.I.T. and Medical entrance foundation courses as permission of Renewal Recognition is given only for school.
26. Sanitary & Soundness certificate should be renewed timely and must be submitted to the District Educational Officer, concerned.
27. The Correspondent is instructed to Renewal Lease deed time to time when it's get expired.
28. TPF Scheme to be implemented to all Teachers.
29. The Management shall renew NOC from Fire Department from time to time without fail.

The recognition now granted is liable for withdrawal by the competent authority for violating the rule as prescribed in the G.O's cited and instructions issued by the authority from time to time.
